

# Privacy Policy

Protecting your private information is our priority. This Statement of Privacy applies to www.qualwire.com and QualWire LLC and governs data collection and usage. For the purposes of this Privacy Policy, unless otherwise noted, all references to QualWire LLC include www.qualwire.com and QualWire. The QualWire website is a Ecommerce site. By using the QualWire website, you consent to the data practices described in this statement.

## Collection of your Personal Information

QualWire may also collect anonymous demographic information, which is not unique to you, such as your:

- Gender
- Race
- Religion

We do not collect any personal information about you unless you voluntarily provide it to us. However, you may be required to provide certain personal information to us when you elect to use certain products or services available on the Site. These may include: (a) registering for an account on our Site; (b) entering a sweepstakes or contest sponsored by us or one of our partners; (c) signing up for special offers from selected third parties; (d) sending us an email message; (e) submitting your credit card or other payment information when ordering and purchasing products and services on our Site. We also may gather additional personal or non-personal information in the future.

## Use of your Personal Information

QualWire collects and uses your personal information to operate its website(s) and deliver the services you have requested.

QualWire may also use your personally identifiable information to inform you of other products or services available from QualWire and its affiliates.

## Sharing Information with Third Parties

QualWire does not sell, rent or lease its customer lists to third parties.

QualWire may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your unique personally identifiable information (e-mail, name, address, telephone number) is transferred to the third party. QualWire may share data with trusted partners to help perform statistical analysis, send you email or postal mail, provide customer support, or arrange for deliveries. ### **Tracking User Behavior**

### **Automatically Collected Information**

Information about your computer hardware and software may be automatically collected by QualWire. ### **Security of your Personal Information**

- SSL Protocol
